This spacious 5-bedroom + loft, 3.5-bath home sits on a premium 11,236 sq ft corner lot at the end of a cul-de-sac and includes two primary suites (one on the main floor), a 3-car tandem garage, upstairs laundry, and a flexible loft space. Upgrades go beyond the surface with 19-panel paid-in-full solar, newer roof, dual high-efficiency A/C systems, TexCote Coolwall exterior coating, whole-house water softener, EV charger, and a fully updated garage system. Inside, the kitchen features granite countertops, stainless steel appliances, and slide-out shelving. The layout includes formal living and dining rooms, dual family rooms, custom built-ins, and elegant stone and hardwood flooring. The private backyard is peaceful and perfect for relaxing or entertaining. Located in a desirable community with HOA amenities including a pool, spa, gym, and clubhouse. The sellers have invested in a wide range of thoughtful upgrades to enhance both comfort and functionality throughout the home. These include a brand new garage door system, a whole-house water softener, and custom garage enhancements such as built-in storage cabinets, a workbench, and expansive



overhead storage. The kitchen features slide-out shelving for added convenience, and the home is protected by a transferable whole-house termite warranty through Terminix. A custom wall unit was added to the main living area, and the exterior has been upgraded with TexCote Coolwall coating, offering improved energy efficiency and durability. One of the standout features is the fully paid 4.41 KW/DC solar power system with 19 panels, along with a Tesla Level 2 EV charger (up to 48A with a 24-foot cable). The home is wired for high-speed optical internet and includes ceiling fans in all bedrooms, recessed lighting in the upstairs loft and reception area, and newly installed high-efficiency HVAC systems for both floors. Additional improvements include a remodeled guest bathroom, accent and pathway lighting throughout the hallways, reinforcement and waterproofing of the master bedroom deck and window, new outdoor lighting, and concealed audio/TV cabling in the master bedroom and main living roomâ€”perfect for wall-mounted screens. These upgrades reflect true pride of ownership and offer excellent value to the future homeowner.
