The entire first level, the stairs and the loft have been upgraded with wood tile flooring for easy maintenance.

The spacious loft can be used as a tv den, play or hobby area. The light filled primary bedroom has a large ensuite bathroom with shower and separate tub and an oversized walk in closet. There are 3 other large upstairs bedrooms and a bathroom. The laundry (washer/dryer incl.) is conveniently upstairs. The front and rear yards have been completely remodeled. The front yard has a widened driveway along with a retaining wall and planter and in the rear all low maintenance pavers and turf have been installed, plus the shade structure stays. There is a tankless water heater and a Ring doorbell and alarm system. The garage has an EV charger (no cable) provided. Spring Mountain community has no HOA, but there are many shared
