The additional downstairs bedrooms are on the opposite side of the primary, and serviced by their own full bathroom. Both those bedrooms have upgraded LVP flooring. When you enter the house, a foyer leads you into a spacious living room. Beyond that, the large kitchen with a gas range and plentiful counter space opens up to a sizable family room. The garage features direct access into the home, and there is also a separate indoor laundry room. A sliding glass door leads you onto the large, covered concrete patio. the .28 acre lot means you have a great sized pool area, and plenty of backyard to spare! The water heater and garage doors are less than a year old, there is brand new carpet in much of the home, and the paint was just professionally touched up prior to sale. Pool heater is less than five years old, and the home features two separate AC condensors. Great location -



walking distance to Citrus Valley High School, and less than five minutes to the 210 and Mountain Grove Shopping Center. Excellent Redlands School district.
