The formal arena measures approximately 120x100 feet, with an additional 100x50 arena, a 50x50 round pen, an 80x80 turnout, a 25x40 turnout, one covered turnout, and a spacious field turnout. Additional equestrian amenities include a two-space wash area, an elevated hay barn, two tack sheds, and a tractor barn that fits a full-sized truck.

But this home is not just for horsesâ€™ itâ€™s smart, sustainable, and energy-efficient. The solar system includes 37 panels, two batteries, and will be pre-paid for the remainder of the lease but includes a 24-year solar equipment warranty. If used wisely, this system could eliminate the need for an Edison bill for the next two decadesâ€™ huge long-term savings for the new owner!

Inside, the home offers 5 bedrooms and 3 full bathrooms with tile flooring downstairs and



luxury laminate upstairs. Every upstairs bedroom features a private patio, and the layout includes two walk-in closets, a tankless water heater, and a newer electric entry gate.
