Step outside to the covered patio, where inlaid pavers extend to a built-in barbecue island and low-maintenance turf - perfect for relaxing or hosting guests. Upstairs, a spacious loft opens to four bedrooms, a full bath, and a conveniently located laundry room. The primary suite impresses with a generous layout, walk-in closet, and an ensuite bath offering dual sinks and a glass-enclosed shower. Additional upgrades include PAID solar (15 panels), an EV charger setup, louvered window shutters throughout, and an attached two-car garage with custom storage cabinets. The Mission Lane community offers robust amenities including a pool, spa, fire pit, parks, playgrounds, and walking trails. From your doorstep, take a scenic 5-mile bike ride or walk along the San Luis Rey River Trail to the
