The showpiece kitchen features modern Shaker cabinetry with CB2 matte black hardware, a handmade Zellige Moroccan tile backsplash with tight grout lines for sheer beauty, and granite countertops with a deep double sink. A suite of Samsung Bespoke matte black appliances, accented with white glass fronts, includes a five-burner gas range with oven, coordinating refrigerator, microwave and dishwasher. A raised ceiling with recessed lighting and an adjacent built-in banquette with custom cushions create a warm, functional dining space ideal for gatherings of up to 10-12.

Both bathrooms have been elevated with designer mirrors, the primary featuring timeless marble flooring and the hall bathroom showcasing large-format porcelain floors and custom shelving.

Throughout the home, brushed European oak engineered wood floors, finished with polyurethane for durability and beauty, add richness. Additional details include 4-inch crown molding, six-panel doors, and textured cut-pile carpet in the bedrooms. Each bedroom also offers a matte black ceiling fan for style and comfort.

Other highlights include a central heater



(installed 2016), dual-pane windows, custom built-in Shaker-style entertainment cabinetry in the living room, and a full-size stacked washer/dryer. For leisure enjoy the HOA common area garden for residents and common area patio with coastal and ocean views!
