Two additional storage units are located in the backyard, one of which has been converted into a dedicated home office, ideal for remote work or quiet productivity. A central ac and heater system, installed in 2023, streamlines household cleaning, while a Phyn smart water assistant and Lyra HIGH-grade environmental sensors offer smart home monitoring and efficiency. The living space includes a cozy gas fireplace with remote control, and the fully upgraded garage features built-in shelving for organized storage. A 2014 fully paid solar panel system provides energy savings, and a water-scale blaster installed on the water line helps preserve plumbing by reducing mineral buildup. Additional amenities include a washer and dryer, backyard furniture, interior sofa, towel warmer, food waste composter, and a Blink smart camera system for added security and peace of mind.
