Truly picturesque. Adjacent is the 5th bedroom (the other 4 are on the other wing of the home), which has its own access, nice for guests or those wanting privacy away from the rest of the home. Nice updates over the years include replaced windows, shutters, removal of box lighting for recessed, bath and more. Truly move-in condition! 3-car garage with tons of storage too. There is no Mello Roos bond in the "Crystal Springs" area of Sand Canyon and only a low annual HOA of \$150 for common area maintenance. Single stories like this are hard to find and homes with this kind
