Recent renovations include kitchen and bathroom upgrades with clean, contemporary finishes and designer touches, wide-plank vinyl flooring throughout the home, and recessed lighting. The updated eat-in kitchen features quartz countertops, a gas cooktop, double oven, and ample cabinetry—ideal for both everyday living and entertaining. Adjacent to the kitchen is a versatile sunlit space with panoramic ocean views, perfect for use as a reading nook, or stylish wine corner, or an ocean-view coffee space. The large family room with a gas fireplace framed by a stone hearth opens to the dining area. Additional improvements include a newly installed central air conditioning and heating system controlled by a Nest thermostat, two Solartube skylights with integrated solar night lights that bring natural light by day and solar glow at night, and newer plumbing all the way to the main line. Outdoor living is equally impressive. The front upper patio offers over 500 square feet of space, perfect for relaxing or entertaining with ocean views as your backdrop. The sliding



glass wall opens to the completely low-maintenance backyard, featuring a built-in BBQ, covered patio area, in-ground jacuzzi, and ample space that can be used for gardening or a small lawn. The two-car garage provides convenient interior access to the home, a side entry door, and natural light via a window. This turnkey residence offers a rare opportunity to enjoy refined coastal living in one of the South Bay's most coveted neighborhoods.
