He was always particularly sensitive to the surrounding environment and would often integrate water and natural landscapes into his designs. His houses are characterized by sweeping rooflines, glass-paneled walls, and steel beams, in a heady combination of fantasy and minimalism. Eschewing architectural orthodoxies, Lautner emphasized geometric shapes such as circles and triangles, incorporating myriad technological innovations.
