Nestled in the sought after Hampton Village community, this impeccably upgraded 2 bedroom, 2.5 bath condo home offers just under 1250 sq. ft. of modern living space, perfect for those seeking a low-maintenance coastal lifestyle. Step inside to discover a bright and airy open-concept layout, featuring wood and Italian stone tile flooring throughout, crown molding, wainscoting, custom lighting, surround sound, wood shutters and much more. The fully remodeled kitchen is a chefs delight, boasting sleek stainless steel high end Jenn-Air appliances (including custom fridge), espresso shaker cabinetry, granite countertops and a full glass tile backsplash. The dining area features a U-Line wine captain for wine aficionados and is literally highlighted by a crystal chandelier that sparkles along with your beverage of choice. While your spacious Living Room, anchored by a cozy fireplace with antique brown granite hearth and built in media niche, leads to your private outdoor garden like patio. Rounding out the downstairs is a powder room bath w/ laundry room and direct access to your 1 car garage. Up next, we ascend the impressive staircase, complete with wood paneling, custom lighting & a skylight. Upstairs we have a dual primary suite layout, with each bedroom offering recessed lighting, a ceiling fan, walk in closet & upgraded en-suite bath. Additional upgrades include a new AC unit w/ ducting & attic



insulation (2024), newer furnace (2016 and rarely used) and new sprinkler system (2022). As an added bonus, Hampton Village is undergoing major renovations, with the pool and spa area being completely redone, updated lighting, new garage doors and a repaving of the entire community. There is no additional cost for the new owner, as the \$21K assessment was already paid in full! There is also a keyed gate with convenient direct access to the Albertsons & CVS shopping center, making for effortless shopping! This is by far the most upgraded Townhouse in the entire city. Someone would need to spend in the low six figures to replicate the improvements done here.
