The open-concept kitchen features quartz countertops, a full quartz backsplash, new double ovens, a cooktop, deep double sink, glass-front cabinetry, trash compactor, built-in desk area, center island, and a walk-in pantry. The kitchen flows directly into the family room, featuring a raised fireplace, and covered outdoor entertainment patio, creating seamless indoor-outdoor living. In addition to the family room, the home offers a separate formal living room and dining room, providing multiple flexible living and entertaining spaces. A conveniently located guest bathroom and a walk in linen closet as well as a separate laundry room provide maximum functionality. The primary master suite is privately located at the back of the home and includes plantation shutters for light and a large closet with an organizer. The remodeled en-suite features tile finishes, updated shower enclosures, new lighting, and modern faucets. The entirely private junior master is separate from the other bedrooms while two additional secondary bedrooms share a third full bathroom with new fixtures. The backyard is designed for



low-maintenance outdoor living and entertaining, featuring artificial turf, a built-in BBQ, Alumawood patio cover, and café lighting for year-round enjoyment. The yard is enclosed with low maintenance vinyl fencing and block wall construction. Additional upgrades include an epoxy-finished three-car garage floor with built-in storage cabinets.
