This beautiful single-story home is located on a quiet cul-de-sac at 24050 Esmeralda Court in Wildomar. Offering 2,733 sq ft with 3 bedrooms plus a dedicated office and 2.75 bathrooms on a 7,840 sq ft lot, this light, bright, and airy home features 9-foot ceilings, bullnose corners, archways, neutral paint, and Republic Flooring commercial-grade laminate flooring throughout the main living areas. The spacious floor plan includes a formal living room, formal dining room, and a large great room with fireplace featuring gas log and wood-burning capability. The kitchen is well appointed with granite countertops, travertine tile backsplash, recessed lighting with dimmer controls, under-cabinet lighting, and pendant lighting over the breakfast bar with seating for four, also equipped with dimmer controls. The kitchen features stainless steel KitchenAid appliances including oven, microwave, dishwasher, and double stainless sink. The flexible layout includes three bedrooms plus a dedicated office with double door entry, perfect for a home office, study, or optional guest space. All bedrooms feature mirrored closet doors. The spacious primary suite features two ceiling fans, a retreat area, sliding glass door access to the backyard, and a large walk-in closet with mirrored wardrobe doors. The primary bathroom offers dual sinks with granite counters, a large soaking tub with armrests by LAGO Luxury Bathware, separate shower, and private toilet area. Additional features include custom ceiling fans throughout, recessed



lighting, indoor laundry room with utility sink and cabinetry, tile flooring in bathrooms and laundry, and a QuietCool whole house fan system that is approximately one year old. The hall bathroom includes a glass tub enclosure. The backyard is designed for entertaining with stamped concrete, an Alumawood patio cover, and a fully equipped outdoor kitchen featuring a Napoleon BBQ, gas burner, sink, refrigerator, and umbrella. The property also features mature landscaping, irrigation systems, subsurface planter irrigation, rain gutters, retaining walls, and perimeter lighting. A finished three-car garage includes built-in cabinetry, ceiling storage racks, and a hot water spigot. Concrete tile roof, stucco exterior, and block and wrought iron fencing complete this exceptional home.
